School trips

Belgium has an exemption in place for under 18 pupils. Visa exemption granted to school pupils who are nationals of a third country listed in Annex I to the Regulation, reside in a third country listed in Annex II to the Regulation and are travelling in the context of a school excursion as members of a group of school pupils accompanied by a teacher from the school in question.

Important - every pupil needs their OWN PASSPORT if they belong to a non-visa exempt nationality (list below).

The "collective passport issued under the Council of Europe Treaty" is (still) accepted as a valid travel document for the three **BENELUX** countries. You will however notice that more and more Schengen countries have already reviewed their policy (in red) and are no longer accepting the travel document or only accept it on certain conditions.

One might consider applying for individual passports if travelling on EU territory and for nationalities who are on the visa obligation list (see above) and want to travel without a visa using the <u>"school trip" exception, they will need their own passport</u>.
